The BDA will be responsible for implementation and overall coordination of NBM within the State. The State Level Agency will have the following functions:-

- Organize base-line survey and feasibility studies in different parts (District, sub-District, or a group of Districts) to determine the status of bamboo production, its potential and i) demand, and tailor assistance accordingly. A cluster based market (industry) led approach needs to be adopted for linking of farmers/FPOs/FPCs/SHGs to markets.
- ii) Work towards setting up of Bamboo Economic Zones as per location of hinterland and industry requirements.
 - iii) Prepare perspective and annual State Level Action Plan in consonance with Mission goals and objectives in close coordination with Bamboo Technical Support Group (BTSG) and oversee its implementation;
 - iv) Receive funds from the State Government and other sources and carrying out the Mission activities, maintain proper accounts thereof and submit utilization certificates to the concerned agencies.
 - v) Furnish periodic progress reports to SLEC for onward transmission to the NBM (DAC&FW), Ministry of Agriculture.
 - vi) Release funds to the implementing organizations and oversee, monitor and review the implementation of the programmes.
 - vii) Assist and oversee the implementation of the Mission's programmes in the State through Farmers Societies, NGOs, growers, entrepreneurs, associations, self-help groups, Stateinstitutions and other similar entities;
 - viii) Organize Workshops, Seminars and skill development/training programmes, participation of artisans in exhibitions/trade fares etc. for all interest groups/associations at the State level.
