## **OFFICE ORDER**

### **TERMS AND CONDITIONS**

- 1. The post is temporary, but likely to be continued.
- 2. The appointee will be on probation for a period of two years w.e.f. from the date of issue of regularization orders.
- 3. The services of the appointee can be terminated at any time by giving one month notice or one month salary in lieu thereof by the appointing authority without giving any reasons.
- 4. The appointee will be given regular pay scale, regular increments and will be entitled to draw all allowances as admissible under the rules.
- 5. The appointee will be governed by the rules and orders in force from time to time as applicable to the H.P. Govt. servants and R& P Rules applicable to the post of Junior Engineer.
- 6. The appointee shall be placed at the lower stage in the seniority of the cadre concerned wherein he/She has been ordered to be regularized. As such, it will not confer any right to him/her for claiming seniority above the Junior Engineers already working in the department on regular basis.
- 7. The appointment is also subject to the verification of character antecedents, which will be got verified later on. In case the character antecedents are not found satisfactory, your services shall be liable to be terminated without giving any notice.
- 8. They should produce certificate of medical fitness issued either by the Chief Medical Officer or Medical Superintendent etc. and countersigned by concerned CMO at first

entry into the Govt. service their joining report will only be accepted on being declared medically fit & submission of Medical Fitness Certificate on the date of joining.

- They shall furnish a declaration to the effect that the appointee have not/shall not have more than one living spouse/shall not marry a person who have a living spouse. They shall furnish declaration regarding marriage that they will not have more than one living wife/husband at any time without the permission of the competent authority.
- Taking the oath of all allegiance/faithfulnesses to the constitution of India and making a 10. solemn affirmation to that effect.
- They shall have to furnish attested copies of their educational qualifications. 11.
- 12. They are liable to be posted anywhere in Himachal Pradesh.
- 13. They shall have to furnish certificate of their moral character from two responsible persons who shall not be in relation to them and they shall belong to institute, they were appointed before present appointment.
- 14. They shall have to report at the place of their posting as per regularization order for which they will not given any travelling allowance.
- 15. All applications made by them for any other posts prior to their joining the post will be treated as cancelled.
- They shall not be allowed to apply for any post outside the Department of Agriculture, 16. HP for one year after their joining on regular post.
- 17. They shall have to furnish a certificate that they have never been terminated from Govt. service/Semi Govt. service.
- 18. They shall have to furnish a certificate issued by the competent authority in respect of Schedule Caste/Schedule Tribe/Other Backward in case they belong to that category to the Head of Office.
- 19. In case, the above mentioned terms & conditions are acceptable to them, they should report for joining the duty alongwith requisite certificates at the place of posting mentioned above against the concerned official within 10 days from the issue of these orders.
