

The Terms & Conditions of engagement of Job Trainee-ADOs shall be as under:-

- (1) He/she shall be engaged as Job Trainee on Group-A post of Agriculture Development Officer(ADO) in Agriculture Department, for a period of two years from his/her joining date, on a monthly consolidated amount of Rs. 29500/-, as decided by the Finance Department vide u.o. diary No. Fin(C)B(15)-4/2016-56423693 dated 20.2.2026.

- (2) He/she will have to submit a certificate of his/her fitness from Deen Dayal Upadhyay (Rippon) Hospital, Shimla. In case of women candidates who are to be engaged for training to carry out hazardous nature of duties, such women candidate, who as a result of tests is found to be pregnant of 12 weeks' standing or more shall be declared temporarily unfit and her engagement shall be held in abeyance until the confinement is over. Such woman candidate be re-examined for medical fitness six weeks after the date of confinement, and if she is found fit on production of Medical fitness certificate from the authority as specified above, she may be engaged to the post kept reserved for her.
- (3) He/she shall give a guarantee in the form of an Affidavit as per **Annexure-A** enclosed herewith.
- (4) He/she shall sign an agreement as per **Annexure-B** appended to these instructions. The service of the Job Trainee-ADO will be governed on the basis of the said agreement. The engagement is liable to be terminated in case the performance/conduct of the Job Trainee-ADO is not found to be satisfactory.
- (5) He/she will have to produce his/her character certificate duly issued by the Executive Magistrate(Civil) or Tehsildar of the concerned region .
- (6) He/she shall not be entitled for any of the benefits as admissible to regular government employee nor can be demand such benefits.
- (7) He/she shall be entitled to travelling and daily allowance as per the provisions of the instructions of the Finance Department issued from time to time, if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart official at the minimum pay scale.
- (8) He/she will be entitled for one day's casual leave after putting in one month's service, 10 days' medical leave and 5 days' special leave, in a calendar year. A female Job Trainee-ADO engaged under this scheme with less than two surviving children, may be granted maternity leave for 180 days'. A female Job Trainee-ADO engaged under this scheme shall also be entitled for maternity leave not exceeding 45 days' (irrespective of the number of surviving children) during the entire service, in case of miscarriage including abortion, on production of medical certificate issued by the authorized Government Medical Officer. He/she shall not be entitled for medical re-imburement, LTC, etc. No leave of any other kind, except above, will be admissible to him/her. Un-availed casual leave, medical leave and special leave can be accumulated upto the calendar year and will not be carried forward for the next calendar year.

Unauthorized absence from the duty without the approval of the Controlling Officer shall automatically lead to the termination of the Job Trainee-ADO engaged under this scheme. However, in exceptional cases, where the circumstances for un-authorized absence from duty were beyond his control on medical grounds, such period shall not be excluded while considering his/her case for regularization/conversion in regular pay-scale but the incumbent shall have to intimate the controlling authority in this regard well in time. However, he/she shall not be entitled for any remuneration for this period of absence from duty.

Provided that he/she shall submit the certificate of illness/ fitness in support of his/her illness, issued by the Medical Officer, as per prevailing instructions of the Government.

- (9) He/she shall be eligible for Medical benefit schemes under HIMCARE/Ayushman Bharat, as applicable, and he/she shall become member of the scheme. The Government medical rules shall not be applicable to him/her.
- (10) Any service Rule including CCS/CCA/Leave Rules/Pension Rule or any other rules, as applicable to government servants, shall not be applicable to these persons engaged under this scheme.
- (11) The person being engaged under this scheme with monthly fixed amount shall have to perform all the duties as assigned by the Competent Authority of the department, in which he/she is engaged.
- (12) He/she shall normally be given training during office hours. However, he/she shall have to perform tasks beyond office-hours, if instructed by the concerned authority.
- (13) The services of the Job Trainee-ADOs engaged under this scheme on completion of two years' period in the relevant financial year shall be considered for regularization in the succeeding financial year, as per instructions issued by the Government from time to time, subject to passing of qualifying examination or efficiency bar test successfully.
- (14) If, at any stage, it is found that the person engaged under this scheme does not fulfill the criteria for the post or ineligible, the incumbent will be relieved after issuing notice according to the conditions of the agreement during the period of engagement. Further, if at any stage, it is found that the person engaged under this scheme is involved in any misconduct, embezzlement, criminal proceedings, sexual harassment at work place, etc. the engagement shall be terminated after affording an opportunity of being heard.

If the offer on the above terms and conditions are acceptable to the above Job Trainee-ADO(s), he/she may report for duty to the Director, Agriculture, Himachal Pradesh, Shimla-05 alongwith all relevant documents/certificates(in original) within fifteen days (from the date of issuance of these orders), positively. He/she is, further, directed to execute the enclosed Agreement as stipulated in condition No. 04 above on the stamp paper. In case, he/she does not report for the duty within the stipulated time period, in that event the offer of engagement as Job Trainee-ADO will stand automatically cancelled.
