3. The applicant should possess minimum 40% permanent Disability Certificate issued by the competent Medical Board i.e. District Medical Board or above. Such certificate in the event of selection for the post will be subject to verification by the competent authority.
4. The candidate/applicant should be bonafide resident of Himachal Pradesh.
5. Incomplete application or received after due date or not in accordance with the prescribed formal shall not be considered and will be rejected straightway without any intimation to the candidate. No correspondence will be entertained in this regard. Therefore, the **candidates are advised to ensure their eligibility for the post and submission of complete application form along with relevant documents/certificates.**
6. The Department will not be responsible for any kind of postal delay.
7. No TA/DA will be admissible.


